History:

Pleasant Green Methodist Church is recognized as the oldest Methodist congregation west of St. Louis. It began among the Walker, Cockrell, Johnson and Forbes families. Under M. B. Evans they formally organized in 1825 and built a log church on 1 ½ acres donated by Winston and Polly Walker, behind their home, called Pleasant Green after an earlier home in Virginia. A log church located at the intersection of two trails, along with a schoolhouse to the west provided shelter until the present structure across the road was built in 1868.

The Old Pleasant Green Cemetery where the church first stood contains burials of five Confederate, one Union veteran and two revolutionary war patriots as well as many slaves
